Exam Structure

100 multiple-choice questions for 3 hours and 2 essay questions for 1 hour-each part.

Essay questions involve both written and quantitative responses.

Professional Membership: Those who aspire to a career in accounting and finance.

Academic Membership: For those who are full-time faculty members of an accredited institution.

Student Membership: For those who are students in an accredited college or university.

CMA Course Duration

Depending on the aspirant's plan and study schedule, the US CMA certificate can be completed in a minimum of 6 months to 3 years. As per the guidelines of IMA, an aspirant must complete the exams within 3 years from the date of registration.

CMA Designation

- ✓ Become the IMA member by registering to enter the certification program
- ✓ Register for the exam
- ✓ Pass both the parts within 3 years from when you are admitted into the certification program.
- ✓ Satisfy the education requirement within 7 years
- ✓ Satisfy with the experience requirement within 7 years
- ✓ Comply with IMA statement of Ethical practice

Eligibility Period

Once candidates are admitted into the Certification Program, they are required to pass both within 3 years. If a candidate is not able to pass both the parts within this 3-year period, the entrance fee will have to be repaid, and the passed part will have to be retaken.

Maintain 30 hours of CPE (Certificate of Continuing Education)
